With reference to school application dated 27.12.2016, I am directed to convey the sanction for Fresh regular Affiliation to the above said school for Secondary School Examination for class IX w.e.f. 01.04.2017 onwards.

The affiliation Code Number allotted to your school is 1720136. This may please be noted and anoted on every correspondence with the Board.

The above sanction is subject to the fulfillment of the following conditions:

The school will follow the national syllabus for the middle classes.

2. The school must follow Uniform System of Assessment, Examination and Report Card for classes VI-IX from Academic Year 2017-18 onwards as per the Board's Circular No:Acad-14/2017, dated 21.03.2017.

3. The school must submit it's information through Online Affiliated School Information System (OASIS) as per the Board's Circular No:CBSE/Aff./4/Circular/2016, dated 10.11.2016, within 30 days from the receipt of this grant letter. Link for OASIS is available on Board's website: www.cbse.nic.in.

4. The school will follow syllabi and courses as per scheme of studies prescribed by the Board for Secondary School Examination and changes made therein from time to time.

The school shall appoint only qualified and eligible staff.

6. The school will help the Board in the smooth conduct of the examination by providing the necessary accommodations i.e. Rooms, Halls, etc. available in the school premises and furniture at its disposal for holding its examinations free of charges if required.

7. The school will spare sufficient teachers, for invigilation purpose at the examinations of the

Board, as may be required.

8. The school will spare its teachers for evaluation of answer-books for the Board's examinations, if required.

9. The school will provide Laboratories, Library and other facilities as per norms of the Board.

10. The school will abide itself by the conditions of affiliation already prescribed or May be prescribed by the Board from time to time

11. Service agreement be executed with the staff as per norms generally accepted by the State Government concerned.

12. Service conditions pay and allowance and other benefits to the employees of the school shall be in no way less than that of corresponding employees working in Government Schools of the State in which the school is located. An undertaking to this effect be sent to C.B.S.E.

13. The school and its records shall be opened for inspection by Director/official of the Board or an authorized representative of the Board/State Educational Department at any time and the school shall furnish information as may be asked for by the Board/State Government from time to time.

14. The rate of tuition fee and other fees charged should be commensurate with the facilities provided.

15 The admission to the school shall be opened to all without any discrimination on the ground of religion, cast or race, place of birth or any of them.

16 No unrecognized classes shall run within the premises of the school or outside in the same name of school.

- 17. The School will not sponsor candidates for Board's examination of any other School/Branch,
- 18. The school will create Reserve Fund as per the requirement of the Affiliation Bye Laws/Rules of the Directorate of Education, Delhi in the joint names.
- 19. The school should not start Class XI/XII without written approval of the Board. The Board shall not be responsible for any consequences in case class XI/XII is started without following the Affiliation Bye Laws and obtaining the prior approval of the Board.
- 20. It will continue to pay Annual Fee of Rs.3,000/- per annum. The schools run by Govt./Govt. Aided are granted regular affiliation and these schools have been advised to remit prescribed annual fee in CBSE by D.D./Cash in favour of Secretary, CBSE, payable at CBSE, H.Q., Preet 21. Annual fee has been received upto 31/03/2019.
- 22. The school is required to contact the concerned Regional Office of CBSE for allotment of school number and password for online Registration of candidates. 23. Special Conditions to be completed within 01 months.
- - 1. The School is required to appoint special educator as per Rule No. 13(11) of Affiliation Bye laws of the Board as mentioned in Board Circular dated 25.06.2015.
 - 2. The School is required to follow the safety guidelines as issued by the Board vide Circular no.19/2017 dated 12.09.2017 captioned "Safety of Children in schools".
 - 3. The school is required to forward /countersigned its application for Fresh Affiliation (Prescribed format) through the Competent Authority of the state.
 - 4. The School is required to submit the safe drinking water certificate issued by the proper competent authority of the state duly signature with stamp of the issuing authority as per Appendix VII II of the Affiliation Bye-laws of the Board.
 - 5. The School is required to submit the fire safety certificate issued by the proper competent authority of the state duly signature with stamp of the issuing authority as per Appendix 6. The school is required to submit fee structure of each class.


